Anything extending from your space will not be acceptable. No set up materials are provided – such as tents, tables, chairs, electrical cords, etc.

NOTE: SNACK/SPECIALTY/ETHNIC ITEMS

Items sold **must** be different than items sold by local community service organizations inside the Cranberry Fest Food tent and be different from other auxiliary food booths. NO duplications. What you list on your application is what you will be allowed to sell. Items should be cranberry related, specialty foods and/or ethnic foods.

Note: Cranberry Fest is a community effort to raise money for the Eagle River community and its not-for-profit organizations. Please avoid the following items at your food booth: Pancake breakfast, hot dogs, bratwursts, shredded pork sandwiches, hamburgers (with or without cheese), shredded chicken breast sandwiches (with or without cranberry sauce), Cranberry sauerkraut meatballs, baked beans, chili, and chicken and rice soup.

NOTE: Applications with full payment and all paper work must be returned to the Eagle River Area Chamber of Commerce and Visitors Center. Booths will be approved as they are received and until all the available spots are filled. Preference is given to those in good standing from the prior year.
