The 42nd Annual Cranberry Fest Exhibitors Committee invites you to apply for participation in our 2022 Cranberry Fest Vintage & Antique Show.

Booth Information (per 12x12 space):

\$50 12' x 12' space on the street Downtown Eagle River

Booth spaces are non-transferable. Booth layout and booth assignments will be determined by the committee.

Event Set Up: Saturday, October 1, 2022 (6:00am—7:30am). Booth assignments are already assigned. All booths are 12'x12' in size and will be clearly marked in the middle of the street. <u>Setup begins after 6:00am on Saturday</u> morning, October 1, 2022 after booth spots are marked. Your booth must be set up by 7:30am on Saturday. <u>Everyone has an assigned booth and you should set up in your assigned area only</u>. If you set up in the wrong space you will have to tear down and move to your assigned spot.

Unloading

Please unload and remove your vehicle immediately. Space is tight and we cannot have vehicles blocking access. You may then return to finish your booth set up. Each vendor is responsible for their own booth materials as well as setup and takedown. Final setup should be completed by 7:30am. We will not allow any vehicles on the street after 7:30am. Please remember to be patient and courteous to other participants and volunteers so setup is an enjoyable experience for all.

Parking

There are several parking lots to park in. Please see the enclosed map detailing parking lots. Crafters should park in the area parking lots and not on the streets. (Suggested parking lot is located on the Southwest corner of Wall Street and Railroad Street – behind Trappers Fireplace Gallery. Do not park right next to the Trappers Fireplace Gallery building.)

<u>Rules</u>: All exhibitors must set-up and exhibit through the end of the event on Saturday, October 1 at 4pm, rain or shine. <u>Exhibitors who do not comply with these rules will not be invited back</u>. The decision of the committee is final. Please allow at least 2-4 weeks for acceptance confirmation.

Permits/Liability Insurance Information:

- All exhibitors are required to have **on file their Wisconsin Seller's Permit number with our office** in order to participate. You may obtain one by contacting the Wisconsin Dept. of Revenue, Income, Sales Inheritance & Excise Tax Division, P.O. Box 892, Madison, WI 53708 or call (608) 266-2776.
- All exhibitors are required to have on file a valid certificate of General Liability Insurance during the show with our office in order to participate.

Cancellation Policy:

Fees must be included with application form and are <u>non- refundable</u> after notification of selection unless the space can be reassigned to another vendor. In this case, there will be a 20% cancellation fee withheld from your refund. <u>There are NO REFUNDS for cancellations within ONE MONTH PRIOR to the event.</u>
